## Eligibility for Legal Aid

Louisiana residents living in one of the 42 parishes west of the Mississippi River; and

whose income is at or below 125%, in some cases 200%, of the current poverty guidelines are eligible for free legal aid; or

who is 60 years or older, regardless of income or assets, through limited funding from Council on Aging organizations.

We have all experienced a disaster in Louisiana at one point or another. Often times we have many questions about what to do next. ALSC can help you work out the details of the following areas:

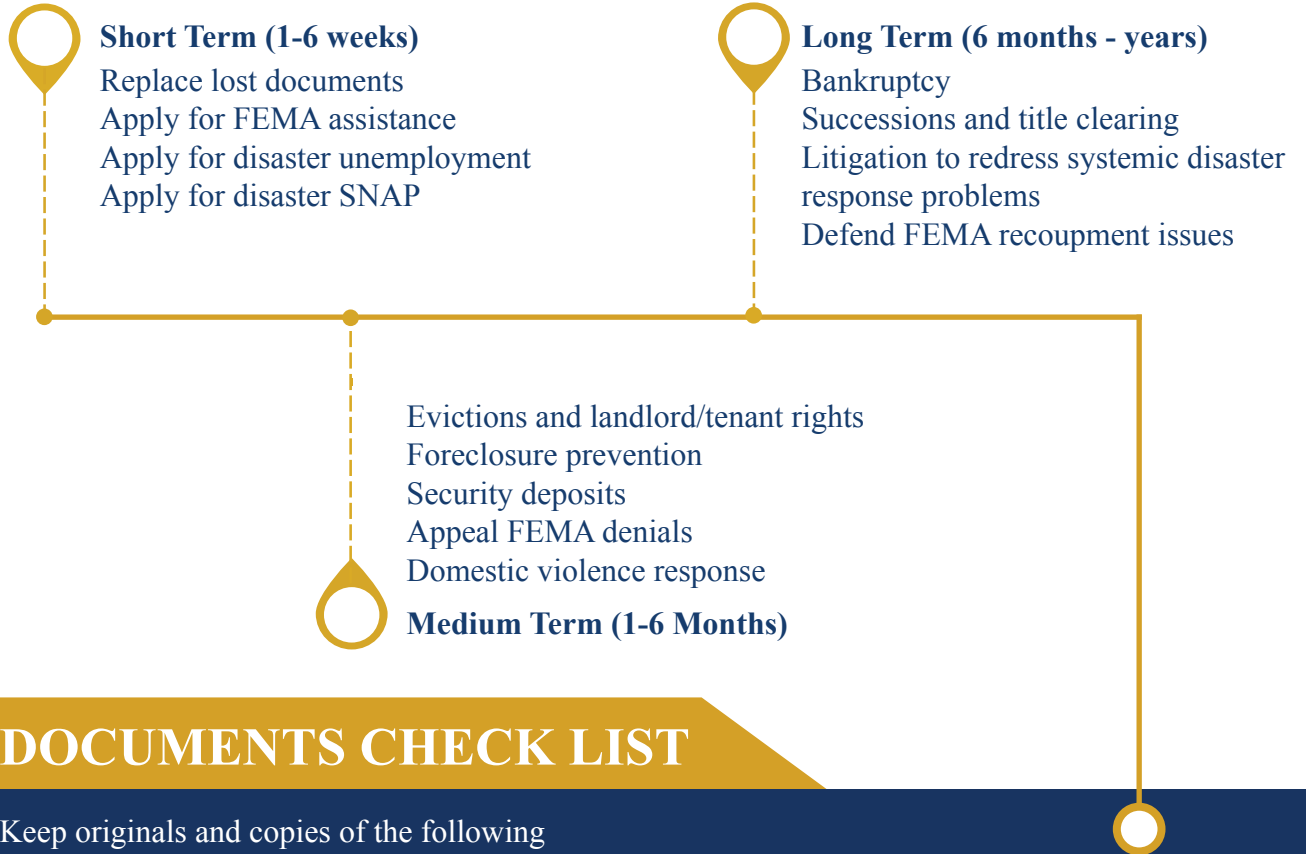

## DOCUMENTS CHECK LIST

Keep originals and copies of the following critical documents with you at all times prior to and during a disaster:

- Personal records (birth, marriage, divorce, adoption and death certificates)
- Passports, driver's licenses and other personal identification documents
- Social Security card(s)
- Property leases, deeds, mortgages and other related records (home and auto titles, etc.)
- Financial documents (pay stubs, bank statements, retirement statements, safe deposit box keys)
- Debit card and credit card numbers
- Medical records (prescriptions, copies of health insurance cards, health provider contract information)
- Family photos, keepsakes and other mementos
