Disaster Legal Timeline

1

SHORT TERM

(1-2 weeks)

Replace lost documents
Apply for FEMA assistance
Apply for disaster unemployment
Apply for disaster SNAP

2

MEDIUM TERM

(1-6 months)

Evictions and landlord/tenant rights
Foreclosure prevention
Security deposits
Appeal FEMA denials
Domestic violence response

3

LONG TERM

(6 months - years)

Bankruptcy
Successions and title clearing
Litigation to remedy systemic disaster response problems
Defend FEMA recoupment issues

FREE legal assistance is available to eligible disaster survivors affected by past events of 2020-2021 natural disasters.

Hurricane Laura, Delta, Zeta, Ida, Winter Storm Uri, and the severe storms, tornadoes and flooding.

Documents List

Keep originals and copies of the following critical documents with you at all times prior to and during a disaster:

- ☐ Personal records (birth, marriage, divorce, adoption and death certificates)
- ☐ Passport, driver's license and other personal identification documents
- ☐ Social Security card
- ☐ Property lease, deed, mortgage and other related records (home and auto titles, etc.)
- ☐ Financial documents (pay stubs, bank statements, retirement statements) safe deposit box keys
- ☐ Debit card and credit card numbers
- ☐ Medical records (prescriptions, copies of health insurance cards, health provider contact information)
- ☐ Family photos, keepsakes and other mementos
